

# 2012 6<sup>th</sup> Annual Christmas Parade

Held on Saturday, Nov. 17, 2012

The line-up for the parade will begin at 5:00 p.m. along Lincoln Street (south of the Elementary School) and the parade will begin promptly at 5:30 p.m. From Lincoln Street it will head North up Vine Street and then turn East on Progress St. – From there participants are free to leave or make their way back to the Elementary School if needed.

This year there will be 3 prize categories. The 3 categories are Best Golf Cart – Best Group – Best use of Lights and the winners will get \$25 each in AAAOC Ready Money to be used at many of the local businesses. The first parade participant (the police car) will be at the corner of Lincoln and Vine, followed by the Boy Scouts Color Guard and our Miss Arthur. The rest of the participants will begin lining up (essentially in first-come order) behind them back down Lincoln and will wrap around the elementary school as needed. Please note that there will be **absolutely no parking** in the staging area. There are plenty of side streets for you to park on close to the elementary school, but please do not park on any side of the elementary school, as these roads will be needed for staging participants.
